## 2. Analysis

The applicant is requesting approval of a plat for Farmstead Sub Area H - Phase 4, south of Hawthorne Parkway and Honey Farm Way, in the Farmstead subdivision. City Council approved the Development Plan for Farmstead in March of 2019, and this plat will formalize the right-of-way and parcels shown on the Development Plan.

The plat includes 26 lots, 1 reserve, and right-of-way dedication for an extension of Honey Farm Way, and a new roadway, Bumblebee End on 5.685 acres. All proposed lots meet the lot size requirement established in the approved zoning text for Farmstead. Additionally, the street layout and easements match what was shown on the approved Development Plan. One reserve will be created with the proposed plat along Jackson Pike, to be owned and maintained by the homeowner's association. This reserve includes a shared-use path easement, which will allow for the extension of the existing shared-use path along Jackson Pike.
